### **BCSC Scholarships**

Donors can choose from 2 named tax deductible scholarship options:

- A "Named **Pass Through** Scholarship" requires a minimum donation of \$500 in any one year. The donation must be received by April 1 for it to be awarded at the May Scholarship Awards Night Ceremony.
- A "Named **Endowed** Scholarship" requires a minimum of \$10,000 which will allow scholarships of \$500 to be given on a yearly basis. Higher donation amounts will increase the amount of the scholarship award. The donation must be received by December 31 of the year prior to the May Scholarship Awards Night Ceremony.

Some donors who need more time to work out logistics of their Endowed scholarship may choose to do a "Named Pass Through Scholarship" for the first year. Subsequent years could then be endowed.

A lump sum donation can also be given to our general fund. At your option, this could be recognized at the May Scholarship Awards Night Ceremony.

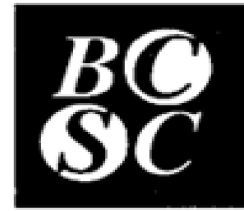
